Storage is allocated on a first come, first served basis with priority given to active, current members in good standing. Members must re-apply for storage space each year with their membership renewal. All decisions are made by the Club Executive. Club members storing boats without approval of the Club Executive will be asked to remove their boat or boats. For your information storage fee calculations are outlined below with measurements to be taken as the maximum length and width of the boat. There will be a minimum charge of \$50. **Road trailers are not allowed to be stored in the compound.** Refer to the attached Storage Policies for further information.
